help give DuPage Legal Aid an updated identity and message of its own. I am so excited to continue building the core of our program and position DuPage Legal Aid for even more growth.

I have always felt that DuPage Legal Aid is a Program of neighbors helping neighbors. The vast majority of our staff and volunteers reside or have an office in DuPage County. Ninety-eight percent of our clients are DuPage County residents. DuPage Legal Aid continues to maintain its volunteer base of over 400 attorneys, and provide free legal assistance to individuals that qualify for our program in primarily family law cases. This year we helped 574 individuals which included monthly Legal Clinics in conjunction with Family Shelter Service and Loaves and Fishes. We continue to enjoy a close relationship with the DuPage County Bar Association (“DCBA”) and screen for their Modest Means and Veterans’ Initiative Program. Additionally, this year we saw our fundraising efforts increase donations by almost 44% more than the prior year. This is thanks to all of the efforts put forth towards Judges’

Nite, our biggest fundraiser of the year. My deepest thanks to all of you who attended Judges’ Nite and contributed to DuPage Legal Aid this year by serving as a Board Member, volunteering to take a case *pro bono*, acting as a committee member, sponsoring a fundraising event, donating to this good cause, and especially to the staff of the DCBA who promote *pro bono* services and help us throughout the year.

We would also like to take the time to thank the Eighteenth Judicial Circuit, the Lawyers Trust Fund, DuPage County Human Services Grant Fund, Naperville Exchange Club, and Milton Township for financially supporting our program and the individuals that we help.

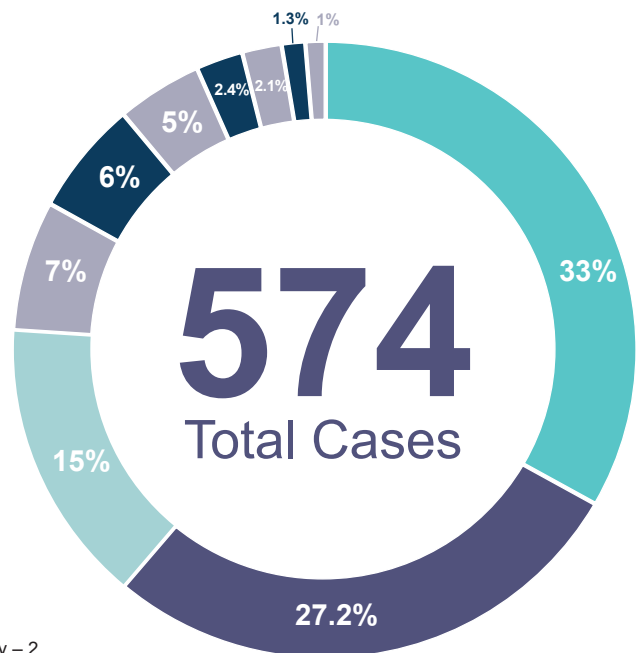
We have closed the 2017-2018 fiscal year, and this year has brought growth for DuPage Legal Aid. Our staff and volunteers were hard at work and, once again, provided over 10,000 hours of *pro bono* legal service in DuPage County for the third year in a row (10,378.8 to be exact). Additionally, I had the pleasure of working with our dedicated Board members and Anchor Advisors to create and complete our new Strategic Plan made possible by an additional and one-time grant given to us from Lawyers Trust Fund. We are so grateful for the opportunity. The Plan is now being implemented and we now have a Mission Statement and Tagline that

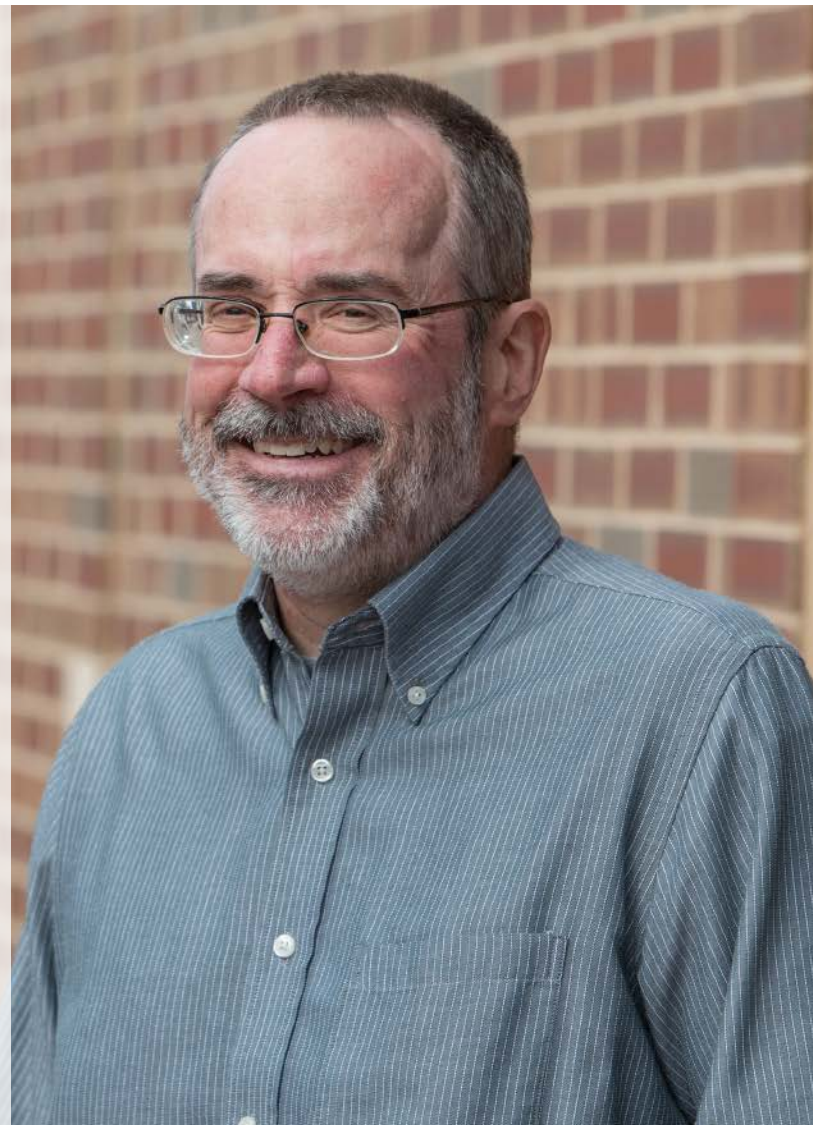
